

FIXED TERM ADDENDUM TO INTERNET SERVICE AGREEMENT

(Before signing, read this document carefully.
it constitutes a legal and enforceable agreement.)

1. INTRODUCTION

Mainstream Fiber Networks, LLC ("MSFN") and the undersigned party ("Subscriber") enter into this Fixed Term Addendum to Internet Service Agreement ("Addendum") as follows:

Reference is made to the INTERNET SERVICE AGREEMENT between MSFN and Subscriber (Agreement") entered into by the parties on the same date as this Addendum. Unless specifically referenced to the contrary herein, the Agreement remains in full force and effect. Any capitalized terms herein and not otherwise defined are defined in the Agreement.

2. FIXED TERM PROVISIONS

The Agreement provides a month-to-month agreement whereby a currently paid up Subscriber may cancel MSFN Services without cancellation fee and MSFN may adjust its pricing on a month-to-month basis. Subscriber has indicated a desire to enter into a fixed fee, twelve (12) month promotion Internet Service Agreement. MSFN is agreeable and offers, and Subscriber hereby accepts, a fixed fee, twelve (12) month promotion Internet Service Agreement subject to the following terms and conditions:

Term of Services delivered by MSFN: TWELVE (12) months

Monthly Fee (Promotional). Subscriber will receive a promotional monthly rate for the first twelve (12) months of service (the "Promotional Term"). Upon expiration of the Promotional Term, the monthly fee will automatically revert to MSFN's then-current, non-promotional monthly rate for the applicable service tier ("Standard Rate"), which is subject to change in accordance with the Agreement.

Note: in the event that Subscriber adds additional Services according to a revised Subscriber's Order Sheet, the fixed monthly fee shall be adjusted up by the then offered price of such additional Services.

Further note: The Monthly Fee set forth above does not include and subscriber is required to pay any taxes, tariffs and fees as set forth in Section 3 of the Agreement.

No Fee Reduction: While the monthly fee may be increased by Subscriber's addition of Services, the Monthly Fee as set forth above shall not be reduced during the Term referenced above.

3. END OF FIXED TERM

At the end of the twelve (12) month promotion, unless the parties have agreed by subsequent written addendum to the contrary, fixed pricing as set forth herein shall end and the Agreement terms regarding a month-to-month term and monthly adjustable pricing shall control at initial pricing according to then current price for Services according to Subscriber's Order Sheet.

4. GIFT CARD PROMOTION

Certain promotional packages may include a gift card in an amount corresponding to the package selected at sign-up (the "Gift Card"). The Gift Card promotion is ancillary to the Services and does not amend the Monthly Fee or any obligations set forth in the Agreement or this Addendum.

Issuance of the Gift Card is expressly conditioned upon:

- (a) Subscriber's submission of a valid order for an eligible promotional package
- (b) Subscriber's continuous "good standing" from the order submission date through the Issuance date (as defined below), meaning no late or returned payments, no past-due balances, and no suspension for non-payment. Failure to satisfy the foregoing conditions shall result in forfeiture of Gift Card
- (c) The Gift Card will be issued after ninety (90) days following Subscriber's submission of the order and delivered via email to the email address on file with MSFN. Subscriber is solely responsible for providing and maintaining a valid email address capable of receiving electronic deliveries. Delivery shall be deemed complete upon MSFN transmitting the email containing the Gift Card.

IF YOU SIGN THIS ADDENDUM, ALL OF THE TERMS AS SET FORTH HEREIN TOGETHER WITH ALL OF THE TERMS OF THE AGREEMENT NOT INCONSISTENT WITH THIS ADDENDUM SHALL BE LEGALLY BINDING ON YOU.
